## SOUTH POINT SUPER FUTURITY

The PCCHA and South Point Hotel and Casino announce a huge addition to the Holy Cow Performance Horses Futurity in 2023. The South Point Super Futurity powered by the PCCHA is a limited-entry Open Futurity that will pay out nearly half a million dollars.

**LAS VEGAS, NEVADA (March 15, 2023):** The Pacific Coast Cutting Horse Association reached an agreement earlier this month which sealed the deal on a brand new opportunity for trainers and owners during this year's PCCHA Holy Cow Performance Horses Futurity this September 21-30. Along with the annual aged events that PCCHA members are accustomed to, the new South Point Super Futurity will be held in conjunction with and in addition to the historical show and will truly be "The best odds in cutting!"

The South Point Super Futurity will not take the place of the Holy Cow Performance Horse Futurity but will serve as an additional opportunity for open trainers and open three-year-old owners to showcase their horses. The limited entry format coupled with a high-risk, high-reward payout schedule is poised to be one of the highlights of the week-and-a-half long show.

"This building (South Point Equestrian Center) is no stranger to high-entry fee, high-payout events like the World Series of Team Roping Finale," said PCCHA Executive Director, Phil Benadum. "We (the PCCHA) thought it past due to give our cutters that same type of opportunity; a chance to win big against a limited playing field during our show."

The draw to enter the South Point Super Futurity is that once the 100-horse limit is reached, there will be a nearly half-a-million-dollar payout in which the top 40 horses will all earn either a cash payout or credit towards entries and fees in the office. The top 20 horses all make money, the top ten double their money or more, and the winning three-year-old will walk away with a haul of prizes plus \$100,000 in cash and South Point gaming chips!

The format of the South Point Super Futurity is straightforward: Entries are limited to 100 horses and there are no limitations to purchasing slots. While owned slots are unlimited, riders can only show three horses and each entry fee is \$5,000 per horse. The top 20 horses from the first go-round will show in the finals. These are truly the best odds in cutting due to the payout extending to horses that place 21st-40th which will all be compensated with a \$2,500 credit at the office!

## RULES & REGULATIONS

**JUDGING & SCORING:** Five (5) judge system will be used following NCHA Rules

**HORSE REGISTRATION:** Horse registry is required on all horses. Proof in the form of a photocopy of the registration certificate or a notarized statement of age & description must be submitted with all entries.

**No horses will be entered into the draw without a copy of the certificate**

**ENTRY FEE: \$5,000 PER ENTRY** (Slot payable in full at the time of purchase)  
(OWNER & RIDER MUST BE CURRENT NCHA & PCCHA MEMBERS IN GOOD STANDING)

### EVENT DETAILS:

- Limited to the first **100 paid entries** (slots)
- You may purchase an unlimited number of slots
- Horses must be 3 years old
- Horse may only be entered one (1) time
- Rider may show no more than three (3) horses
- Draw will be posted a minimum of 24hrs prior to first go-round

### ADVANCEMENTS:

- The top 20 highest scoring horses **plus ties** will advance to the finals
- In the event of a tie for first, **a work off will determine the champion**

### TIE-BREAKER:

### PAYOUT (100 Horses):

- No go-round money. All Finalists receive a check based on the number of fully paid entries. (See Projected Payout Schedule on Next Page)
- 21st-40th receive a \$2,500 office credit to be used towards entry fees, stalls, and practice pen works **ONLY** at the 2023 PCCHA HCPH Futurity
- Champion and Reserve Champion Awards will be presented in the arena

## SLOT TRANSFERS | PCCHA SHOW MANAGEMENT | UNPAID BILLS

Slots are fully transferable and any transfer must be communicated in writing to show management no later than 5 PM, September 14, 2023. Entries or slot transfers after this deadline will be charged a late fee and/or transfer penalties. The horse and rider for each slot must be declared to show management no later than five days before the go-round. The PCCHA Executive Committee reserves the right to make any changes, additions, deletions, or interpretation of these rules as deemed necessary by them. Notice of any changes will be posted at the show and/or upon request. Show management reserves the right to cancel said event, without notice, any time prior to the contest. In such event, slot/entry fees pertaining to this event will be refunded. Any unpaid fees/accounts left open at the close of the show will be charged a 15% fee and remanded to NCHA for collection after 90 days.
