PCCHA RV Reservation & Parking Policies

- **RV Space** – Restricted to 1 RV or Living Quarters Trailer.
- **Reservation** – Must be made on or before February 10th, 2019 to ensure availability
- **Space Fees** - **\$250** entire Event w/Water & Electricity or **\$50/day** if space is available
- **\$10** per day, Dry Camp Only
- **Payment** – Must be paid in full and accompany reservation.
- **Pop Outs & Awnings** – Please indicate location of all, on sample unit below
- **Space Assignments** – To be made on a 1st come, 1st serve basis.
- **Sideways Parking** - Will not be allowed.
- **Park By** – Every effort will be made (if indicated below) to park you by the person designated.
- **Move In Date** – **Sunday, March 3rd, 2019. Move in will not be allowed prior to this date.**
- **Arrivals** – **Our Welcoming Committee will be on hand to assist with your parking & setup needs. It will more than likely be very busy the first few days. Your patience and understanding will be greatly appreciated.**
