PCCHA STALL RESERVATION & STABLING POLICIES

- **Tack Rooms** – Are **required** due to location of trailer parking.
- **Trailer Parking** – across the street from South Point-no horses allowed in parking lots.
- **Payment** – Must be paid in full and accompany reservations. No stall shall be considered rented unless payment in full has been received.
- **No Refunds** – There will be NO REFUNDS on any reserved stall.
- **1st Bedding & Mats** – Included is the 1st bedding of 4 bales in each stall. Stall mats available for an additional \$40/Stall (2 mats/stall.) Additional shavings available for purchase upon arrival at the South Point store.
- **Stalls for Turnback Horses** are granted free of charge but **Must** be ordered through the office and approved by show management.
- **Move In Date** – Tuesday, September 29th. Move in will not be allowed prior to this date.
- **South Point Arena requires all contestants to leave an open check, credit card or room number With the SP Store for all additional charges. Thank you**
